DEBT MANAGEMENT

1. General Obligation Authorizing Resolution – 2011 State of Wisconsin Building Commission Resolution 14 authorizes the issuance and sale of General Obligations in an amount not to exceed \$270,990,000 in fixed or variable rate form, to fund the construction or improvements of facilities, grants, and acquisition of land for state-wide purposes.
2. Transportation Revenue Obligations Authorizing Resolution – 2011 State of Wisconsin Building Commission Resolution 15 authorizes the issuance and sale of State of Wisconsin Transportation Revenue Obligations in an amount not to exceed \$200,000,000 in fixed or variable rate form.

4. Departments of Agriculture, Trade and Consumer Protection and Wisconsin State Lab of Hygiene Agricultural and Public Health Laboratory, Madison
 – Request authority to increase the budget by \$1,400,000 WSLH Agency Cash to accept a bid alternate for a revised total budget of \$29,935,000 (\$20,850,000 General Fund Supported Borrowing, \$7,685,000 Program Revenue Supported Borrowing, and \$1,400,000 WSLH Agency Cash).

In November 2010, the Building Commission approved the design report and construction of the project at \$28,535,000 (\$20,850,000 General Fund Supported Borrowing and \$7,685,000 Program Revenue Supported Borrowing).

7. Pecatonica State Trail, Belmont – Request the following:
 - a) Provide \$249,000 Stewardship Borrowing, for the local share to match a \$996,000 Federal Transportation Enhancement Grant that will design and construct a 7.3 mile segment of the Pecatonica State Trail (total project cost is estimated at \$1,245,000), linking the Village of Belmont, the City of Platteville, UW-Platteville, and the old USH 151 business corridor; and
 - b) Waive s. 16.855, under s. 13.48 (19), to allow the Department to enter into an intergovernmental agreement with Lafayette County and pay the local share of the Transportation Enhancement project.

8. Wisconsin School for the Deaf and Hard of Hearing, Delavan – Request approval of the following:
