Subject: Classification Plan Changes for **WSEU Blue Collar, Security and Public Safety, and Technical Bargaining Units** related to the 2003-2005 labor contracts

Pursuant to s. 230.09, Stats., the Director of the Office of Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is July 24, 2005**, unless otherwise stated. Details on the pay processing instructions to accompany implementation of these class plan changes are contained in Bulletin OSER-0069-CLR/LR/PP.

1. **Abolish the Experimental Farm Laborer, Experimental Herd Assistant-Objective and -Senior, Laboratory Animal Technician 1, 2, 3 and Poultry Worker-Objective and -Senior** classifications, **effective July 24, 2005**. Positions affected by this action will be reallocated to the Animal Research Technician classification series. See item # 6 below for more information. Questions may be directed to Leean White at (608) 267-0344.
2. **Create the Cheesemaker** classification, **effective July 24, 2005**, to describe select positions located at the University of Wisconsin-Madison Dairy Plant and *modify* the Dairy Plant Assistant-Entry, -Senior and -Advanced classification specification to specifically exclude positions that function as cheesemakers a majority of the time. UW-Madison will process affected reallocation notices. Reallocations related to the implementation of the Cheesemaker classification is delegated to UW System Administration. 3. **Abolish the Weights and Measures Inspector-Entry** classification, **effective July 24, 2005**, as this level will not be used in the future. Questions may be directed to Leean White at (608) 267-0344.
4. **Reassign the Pay Ranges** for the classifications of: **Animal Health Consultant, Animal Health Inspector-Entry and -Objective, Food Safety Consultant, Food Safety Inspector – Entry and -Objective, Meat Safety Consultant, Meat Safety Inspector – Entry and -Objective, Multiple Products Grader-Entry and -Objective, Weights and Measures Inspector-Developmental and -Objective, and Weights and Measures Technical Specialist, effective July 24, 2005**, as a result of negotiation of the 2003-2005 labor contract between the State of Wisconsin and the Wisconsin State Employees Union. The Department of Administration Central Payroll and University of Wisconsin Employee Compensation and Benefits Services will automate these transactions. 5. **Abolish the Equipment Fabricator-Entry, -Journey and -Senior and the Forestry Equipment Technician** classification series, **effective July 24, 2005**, and reallocate the affected positions to the Forestry Technician-Advanced classification as noted in item # 7 below. Questions may be directed to Leean White at (608) 267-0344.
6. **Create the Animal Research Technician, Animal Research Technician-Objective/Intermediate, Animal Research Technician-Senior and Animal Research Technician-Advanced** classification series **effective July 24, 2005**, to replace the classifications being abolished in item # 1 above. Implementation of this classification series is delegated to UW System Administration. University of Wisconsin Employee Compensation and Benefits Services will automate these transactions. Questions may be directed to Leean White at (608) 267-0344.

7. *Modify* the **Forestry Technician** classification series, **effective July 24, 2005**, to include positions at the LeMay Forestry Center within the Department of Natural Resources. Reallocation notices will be processed by the Department of Natural Resources. Positions formerly classified as Equipment Fabricator-Entry, -Journey and -Senior are reallocated to the Forestry Technician series. Refer to item # 5 above. Questions may be directed to Leean White at (608) 267-0344.
8. *Create* the **Research Vessel Captain** and **Research Vessel Crew Leader** classifications, **effective July 24, 2005**. Reallocation of positions from the Research Technician classification series are being reallocated to these new titles. Implementation of the Research Vessel Captain and Research Vessel Crew Leader is delegated to the Department of Natural Resources. Questions may be directed to Leean White at (608) 267-0344.
