Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is January 7, 2007**, unless otherwise stated.

- 1) *Abolish* the **Natural Resources Southeast Region Business Supervisor** classification, **effective January 7, 2007**, as this position was incorporated in the Natural Resources Program Supervisor classification and will no longer be used. No reallocation notices are necessary for this action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 2) *Modify* the **Employment Programs Coordinator** classification specification, **effective January 7, 2007**, to describe the full range of duties (job development, job placement, assessment, etc.) and to add representative positions within the Department of Corrections. No reallocation notices are necessary for this action. Questions may be directed to Stephen Hermosillo at (608) 266-0714.
- 3) *Modify* the **Health Services Specialist 1, 2** classification specification, **effective January 7, 2007**, as a result of reorganization and renaming of the DHFS Office of Quality Assurance and the refocus of the Office to include assisted living, AODA, and mental health services with the implementation of WI Admin. Code HFS 83 and HFS 75. No reallocation notices are necessary for this action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 4) *Modify* the **Institution Registrar** classification specification, **effective January 7, 2007**, to describe positions located at the Department of Corrections – Division of Community Corrections (DCC) that ensure the lawful extradition of DCC absconders back to Wisconsin. No reallocation notices are necessary for this action. Questions may be directed to Stephen Hermosillo at (608) 266-0714.
- 5) *Modify* the **Licensing/Certification Specialist** classification specification, **effective January 7, 2007**, to remove the allocation for positions located within the DHFS Bureau of Program Quality Compliance (renamed to Office of Quality Assurance) who provide licensing/certification services to health services facilities. These positions are included within the Health Services Specialist 1 classification. The affected agency will process necessary reallocations for this action. - 6) *Modify* the **Natural Resources Program Supervisor** classification specification, **effective January 7, 2007**, to reflect current allocation patterns and representative positions within the DNR as well as to include the position previously classified as NR Southeast Region Business Supervisor. 
