Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, **the effective date is September 2, 2007**, unless otherwise stated.

1. **Abolish** the **Education Consultant Coordinator** classification, **effective September 2, 2007**, as a result of the Education Professional Personnel Management Survey. These positions are being incorporated in the Education Consultant due to classification simplification. 2. **Abolish** the **Regional Water Program Expert** classification, **effective September 2, 2007**, to reflect the current use of the water classifications with The Department of Natural Resources' realignment of the water program. The positions were incorporated into the Water Resources Management Specialist-Advanced and the Water Regulation and Zoning Specialist-Advanced classifications. 3. **Modify** the **Collections Specialist** classification specification, **effective September 2, 2007**, to include multiple positions at the Collections Specialist-Senior level within the Department of Workforce Development. 4. **Modify** the **Contracts Specialist** classification series specification, **effective September 2, 2007**, to reflect organizational changes at the Department of Transportation from a district to a regional structure and to update the other represented positions. 5. **Modify** the **Education Administrative Director, Education Consultant, Education Program Coordinator, Education Program Specialist, Education Specialist, Library Consultant, Public Instruction Supervisor and School Administration Consultant** classification specifications, **effective September 2, 2007**, as a result of the Education Professional Personnel Management Survey. 8. **Modify** the **Youth Counselor-Advanced** classification specification, **effective September 2, 2007**, to remove the position at Southern Oaks Girls School and to add a new position designated Due Process. 9. **Modify** the **Water Regulation and Zoning Specialist and Water Resources Management Specialist series** classification specifications, **effective September 2, 2007**, to incorporate allocations from the Regional Water Program Expert classification which is being abolished and to reflect the current structure and realignment of the water program within the DNR.
