
1. *Modify* the **Child Care Counselor 1, 2 and 3** classification specification, **effective December 9, 2007**, to clean up old language, put specification in proper format and add one allocation for Wisconsin School for the Deaf. 2. *Modify* the **Industries Superintendent** classification specification, **effective December 9, 2007**, to reflect current job duty definitions within the Department of Corrections. 6. *Modify* the **Produce Inspector, Produce Inspector-Leadworker, and Produce Inspector-Supervisor** classification specifications, **effective December 9, 2007** to reflect minor changes to the divisional information. The division was renamed from Marketing to Trade and Consumer Protection, so the positions are no longer based out of the Marketing Division. The format of the specification was also updated and "objective" was removed from the title of Produce Inspector. No reallocation notices are necessary for this action. 7. *Pay Range Reassignment* for the **Nurse Practitioner MGT, and Nursing Supervisor** classifications, **effective December 9, 2007** to reflect a newly created pay range for certain non-represented nursing classifications, currently assigned to pay range 81-03, to more accurately reflect the labor market.
