Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is January 6, 2008**, unless otherwise stated.


1. *Change the Title of Director, Wisconsin Council on Developmental Disabilities to Director, Board for People with Developmental Disabilities* and *Modify* the classification specification, **effective January 6, 2008**, to change the name of the agency and remove all reference to the Department of Health and Social Services. The Board for People with Developmental Disabilities is created as part of the Governor's biennial budget and is attached to the Department of Administration for administrative purposes. The Department of Administration will process any necessary reallocation notice. Questions may be directed to Toriana Pettaway at (608) 266-8434.
 2. *Modify* the **Food Service Administrator** classification specification, **effective January 6, 2008**, to add an allocation for the Department of Veterans Affairs. The Department of Veterans Affairs will process any necessary reallocation notices. Questions may be directed to Dean Paynter at (608) 266-1014.

3. Publish notice, on behalf of the University of Wisconsin Hospital and Clinics (UWHC), of the abolishment, creation and/or modification of the classification structure for positions employed by the UWHC Board, as negotiated between the UWHC and the Wisconsin State Employees Union. Use of these classifications is limited exclusively to the UWHC and the specifications will not be posted on the Office of State Employment Relations' Web Page, although the titles will appear in a section of the Alphabetical Listing of Classifications devoted exclusively to UWHC classification listings.  - a) Effective **retroactive to October 8, 2007**, abolish the **Senior level of the Nursing Assistant** classification.
