Subject: Miscellaneous Classification Plan Changes as a Result of the Teacher Assistant, Media Telecommunications and Instrument Maker Surveys

Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified in this bulletin, as a result of survey implementation. New classifications have been assigned to the pay ranges negotiated between the State of Wisconsin and the Wisconsin State Employees Union Technical Bargaining Unit for the 2007-2009 labor agreement. Regardless of the actual notification date, the **effective date is October 12, 2008**, unless otherwise stated.

- 1) *Abolish* the **Teacher Assistant** classification, **effective October 12, 2008**. Reallocation notices will be automated and processed by DOA Central Payroll and/or University of Wisconsin Payroll. - 2) *Create* the **Educational Assistant-Entry, Educational Assistant-Objective, Instrument Maker Specialist, Media Telecommunication Technician and Media Telecommunication Technician-Senior** classifications, **effective October 12, 2008**, as a result of survey implementation. Reallocation notices will be automated and processed by DOA Central Payroll and/or University of Wisconsin Payroll. 
