**Subject:** Miscellaneous Classification Plan Changes as a Result of the Boiler Safety and Elevator Safety Surveys

Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified in this bulletin, as a result of survey implementation. New classifications have been assigned to the pay ranges negotiated between the State of Wisconsin and the Wisconsin State Employees Union Security and Public Safety Bargaining Unit for the 2007-2009 labor agreement. Regardless of the actual notification date, the **effective date is October 12, 2008**, unless otherwise stated.

- 1) *Abolish* the **Boiler Safety Inspector and Elevator Safety Inspector** classification series, **effective October 12, 2008**. Reallocation notices will be automated and processed by DOA Central Payroll and/or University of Wisconsin Payroll. - 2) *Create* the **Boiler Safety Inspector-Entry, -Intermediate, -Advanced and Elevator Safety Inspector-Entry and Objective** classifications, **effective October 12, 2008**, as a result of survey implementation. Reallocation notices will be automated and processed by DOA Central Payroll and/or University of Wisconsin Payroll. 
