**Subject:** Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the effective date is April 12, 2009, unless otherwise stated.

- 1) *Modify* the **Engineering Specialist–Transportation** classification series, effective April 12, 2009, to update the definitions to include positions that perform a combination of duties in the allocations listed. - 2) *Modify* the **Public Health Sanitarian** classification series, effective April 12, 2009, to reflect Department of Health Services name changes; to expand allocations at the advanced level; to accommodate the shift of inspection activity to eliminate redundancy in state level public health functions; and to clarify the responsibility of the DATCP Public Health Sanitarian Advanced as they relate to program evaluation and compliance.
