Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is December 6, 2009**, unless otherwise stated.

- 1) *Abolish code 98103, Office of Governor NTE ESG 3, **effective December 6, 2009***. This code is no longer used. No reallocation notices are necessary for this action. Questions may be directed to Paul Ostrowski at (608) 267-0343.
- 2) *Modify the **Disability Claims Reviewer** classification and the **Disability Determination Specialist** classification series specifications, **effective December 6, 2009***, to accommodate the reorganization and renaming of the Department of Health Services and its divisions and bureaus.
