Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is March 14, 2010**, unless otherwise stated.

- 1) *Create* the **Psychologist Supervisor – Chapter 980** classification, **effective March 14, 2010**, to describe positions located at the Departments of Corrections and Health Services that manage and supervise the state's specialized units for evaluating persons as a result of the Chapter 980, Sexually Violent Person Commitment law. Reallocation notices will need to be processed by the agency to implement this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 2) *Create* the **Treatment Supervisor – Chapter 980** classification, **effective March 14, 2010**, to describe positions located in the Department of Health Services at Sand Ridge Secure Treatment Center supervising direct treatment services to patients detained or committed under Chapter 980, Wis. Stats. Reallocation notices will need to be processed by the agency to implement this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 3) *Modify* the **Civil Engineer-Transportation Supervisor** classification, **effective March 14, 2010**, to clarify classifications supervised and to update the qualification section to reflect current requirements of Supervisory level positions in the Division of Transportation System Development. No reallocation notices are necessary to implement this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 4) *Modify* the **Revenue Administrative Manager** classification, **effective March 14, 2010**, to add the allocation of Chief, Technical Services & Privacy Office in the Department of Revenue. Reallocation notices will need to be processed by the agency to implement this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 5) *Modify* the **Revenue Field Auditor 6** classification, **effective March 14, 2010**, to reflect the similarity in complexity between reviewing and selecting field audits.
