Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is November 4, 2012**, unless otherwise stated.

- 1) *Create* **Corrections Investigator** classification specification for the Department of Corrections. As part of the newly created Office of Inspector General, this classification is created to carry out the responsibilities of the Professional Standards and Prison Rape Elimination Act (PREA) Unit by conducting personnel investigations into allegations of supervisory misconduct, serious staff misconduct and PREA violations. No reallocation notices will be necessary to accomplish this classification action. Questions may be directed to Lynn Kirsch at (608) 266-2705.
- 2) *Create* the **Criminal Analyst Supervisor** classification specification for the Department of Justice to accommodate the need for supervisors to be skilled in areas of computer intelligence and evidence analysis. - 3) *Modify* the **Clinical Coordinator** classification specification for the Department of Health Services and the Department of Veteran Affairs to update the definitions that include positions located at the Wisconsin Resource Center. - 4) *Modify* the **Dentist-Supervisor; Dentist- Management** classification specification for the Department of Corrections and Department of Health Services to remove the allocation of Dentist-Supervisor at the Northern Wisconsin Center at the Department of Health and Family Services, to update the name of the Department of Health Services and to add an allocation for the State Dental Officer at the Department of Health Services.
