
Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is July 14, 2013**, unless otherwise stated.

- 1) *Create* the unclassified **Assistant Deputy Secretary** series in accordance with 2013 Wisconsin Act 20 **effective July 1, 2013**. Questions may be directed to Paul Ostrowski at (608) 267-0343.
- 2) *Modify* the **Budget and Policy Manager** classification for the Department of Administration to add an allocation to account for the splitting of the Division of State Facilities into two divisions. No reallocation notices are necessary to accomplish this classification action. Questions may be directed to Chelsea Daley at (608) 267-5165.
- 3) *Modify* the **Corrections Administrative Supervisor** classification for the Department of Corrections as a result of the reorganization of the Electronic Monitoring Center. The representative positions for the Division of Adult Institutions were updated to reflect current duties and the Division of Community Corrections representative positions were removed. - 4) *Modify* the **Corrections Administrative Unit Supervisor** classification for the Department of Corrections. Due to advances in electronic monitoring technology and new laws requiring an increased number of people on electronic monitoring systems, the duties, training needs, and staff supervision were updated. - 5) *Modify* the **Corrections Security Chief** classification for the Department of Corrections to address the need for a statewide security program focus in the central office. - 6) *Modify and Change DP Code* the **Corrections Security Director** classification for the Department of Corrections to address the need for a statewide security program focus in the central office. - 7) *Modify and Change CIC Code* the **Public Health Nutrition Section Chief** classification for the Department of Health Services with updating the qualifications language and the name of the Department of Health Services.
