Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is February 9, 2014**, unless otherwise stated.


- 1) *Create* the **Chief, Weights & Measures Field Operations** classification and *Abolish* the **Chief, Regulations & Safety Section** classification due to the merging of the Department of Safety and Professional Services' petroleum program into the Department of Agriculture, Trade and Consumer Protection in July 2013. - 2) *Modify* the **Fire/Crash Rescue Specialist** classification series (all levels) for the Department of Military Affairs to document additional special requirements needed to meet compliance with Federal guidelines. - 3) *Modify* the **Revenue Section Chief** classification for the Department of Revenue to add the allocation of Compliance Services Section Chief and update the descriptions of the current allocations.
