Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is May 3, 2015**, unless otherwise stated.

- 1) *Abolish* the **Power Plant Assistant** classification as this classification specification is no longer utilized by any state agency, and no future use is planned. - 2) *Create* the **Veterinary Supervisor** classification for the Department of Agriculture, Trade and Consumer Protection to provide a classification to supervise veterinarian field staff. - 3) *Modify* the **Child Care Subsidy Specialist** classification series, effective April 19, 2015, for the Department of Children and Families to update the definition language at the objective level to better reflect the needs of the agency and remove entry from the Child Care Subsidy Specialist level and the schedule/range information from the classification specification. - 4) *Modify* the **Disability Determination Specialist** classification series for the Department of Health Services to update the definition language to reflect the increased training and experience required at the objective level. - 5) *Modify* the **Employment and Training Specialist** classification for the Department of Workforce Development, effective April 19, 2015, to update the definition language and identify three distinct allocation patterns within the specification. - 6) *Modify* the **Human Services Program Coordinator** classification series to include positions at the Department of Veteran Affairs and to update some representative positions. - 7) *Modify* the **Institution Treatment Director** classification, for the Department of Health Services, to update the definition language to better define positions that function as Program Directors at Institutions and Centers.
