
**Subject:** Implementation of the Offender Records  
Assistant Personnel Management Survey,  
Miscellaneous Classification Plan Changes

Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is May 29, 2016**, unless otherwise stated.

- 1) *Abolish* the **Offender Records Assistant 1, 2, 3** classification series for the Department of Corrections and Department of Health Services as part of the Offender Records Assistant Personnel Management Survey as this classification series is obsolete and will no longer be utilized by any state agency. Reallocation notices for this classification action will be processed by the Division of Personnel Management, but necessary forms and notifications will be completed by the affected agencies. Questions may be directed to Peter Flood at (608) 266-8149.
- 2) *Create* the **Corrections Sentencing Associate** classification series for the Department of Corrections and Department of Health Services as part of the Offender Records Assistant Personnel Management Survey to classify positions that perform sentence computation functions for a majority of the time. Reallocation notices for this classification action will be processed by the Division of Personnel Management, but necessary forms and notifications will be completed by the affected agencies. Questions may be directed to Peter Flood at (608) 266-8149.
- 3) *Create* the **Offender Records Associate** classification for the Department of Corrections and Department of Health Services as part of the Offender Records Assistant Personnel Management Survey to classify positions that perform records office support functions relating to offender/patient files for a majority of the time. Reallocation notices for this classification action will be processed by the Division of Personnel Management, but necessary forms and notifications will be completed by the affected agencies. Questions may be directed to Peter Flood at (608) 266-8149.
- 4) *Modify* the **Institution Registrar** classification as part of the Offender Records Assistant Personnel Management Survey to update the definition language to better reflect work being performed by the positions, and to limit this classification's use to only positions within the Department of Health Services' Mendota or Winnebago Mental Health Institutes. Reallocation notices for this classification action will be processed by the Division of Personnel Management, but necessary forms and notifications will be completed by the affected agencies. Questions may be directed to Peter Flood at (608) 266-8149.
- 5) *Modify* the **Offender Records Supervisor** classification as part of the Offender Records Assistant Personnel management Survey to update the definition language to better reflect work being performed by the positions, and to open the classification specification for use by the Department of Health Services. Reallocation notices for this classification action will be processed by the Division of Personnel Management, but necessary forms and notifications will be completed by the affected agencies. - 6) *Retitle* the **Agriculture Program Specialist-Objective** classification to **Agriculture Program Specialist**, **effective May 15<sup>th</sup>, 2016**, to reflect changes to the classification series. There are no reallocations necessary for this classification action, but affected agencies should notify employees of the change. Questions may be directed to Peter Flood at (608) 266-8149.
