STATE OF WISCONSIN General Obligation Bonds of 1995, Series B (AMT) Dated February 15, 1995 Maturing 2016, 2020 and 2025

Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1995, Series B (AMT) (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds from prepayments of veterans housing loans financed by public debt issued for such purpose, that some of the Bonds maturing on 2016, 2020 and 2025 have been called for redemption on December 1, 2002 prior to their maturity at the price of 100% of their principal amount plus accrued interest to December 1, 2002.

On and after December 1, 2002 interest will cease to accrue on the principal amount so called for redemption.
