Notice is hereby given to CEDE & CO., the owner of the State of Wisconsin General Obligation Bonds of 1999, Series D (Taxable) (the "Bonds"), pursuant to Section 1.06(c) of the authorizing resolution providing for the special redemption of the Bonds, that a portion of the outstanding Bonds maturing on November 1, 2010 and 2030 have been called for redemption on July 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to July 1, 2003.

On and after July 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
