Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1997, Series A (AMT) (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds, that a portion of the Bonds maturing on May 1, 2028 have been called for redemption on July 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to July 1, 2003.

On and after July 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
