Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1999, Series B (Taxable) (the "Bonds"), pursuant to Section 1.06(c) of the authorizing resolution providing for the special redemption of the Bonds, that a portion of the Bonds maturing on November 1, 2003 through 2010, 2013, 2016 and 2030 have been called for redemption on October 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to October 1, 2003.

On and after October 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
