Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Refunding Bonds of 1997, Series 1 (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds, that all of the outstanding Bonds maturing on May 1, 2013 through 2014 and a portion of the Bonds maturing on May 1, 2015 have been called for redemption on October 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to October 1, 2003.

On and after October 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
