Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1995, Series B (AMT) (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds from prepayments of veterans housing loans financed by public debt issued for such purpose, that all or a portion of the Bonds maturing on 2016, 2020 and 2025 have been called for redemption on February 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to February 1, 2003.

On and after February 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
