On June 29, 2015, the State will redeem a portion of the outstanding bonds maturing May 1, 2031 and all of the outstanding bonds maturing May 1, 2037. The enclosed Notice of Redemption is being sent to you pursuant to the Blanket Issuer Letter of Representations, dated May 27, 2005, between the State of Wisconsin Building Commission and The Depository Trust Company ("DTC"). The Operational Arrangements requires that DTC be notified not less than thirty days prior to the date of redemption. You will have this letter and the Notice in your possession on May 29, 2015, a date which is equal to or more than thirty but less than sixty days prior to the proposed date of redemption, and corrected on June 1, 2015.
