Re: Badger Fund of Funds Report for the Fiscal Quarter Ended June 30, 2024

Dear Limited Partners,

We are pleased to report on the progress achieved by the Badger Fund of Funds (the "Badger Fund") during the quarter ended June 30, 2024. In accordance with Section 7(c)(i) of the Limited Partnership Agreement of the Badger Fund, SMK will provide a report after the end of each fiscal quarter.

Last quarter we reported that 2023 Wisconsin ACT 98 was signed into law. ACT 98 made improvements to the Badger Fund program. In addition, the 2023-25 biennial budget signed by Governor Evers appropriated \$25 million dollars for an additional round of funding to the program. SMK has two years from April 3, 2024, to make new investment commitments to Wisconsin-based venture capital funds.

The first investment commitment from this additional round of funding was to Idea Fund II of La Crosse in April 2024. The Idea Fund announced the final close of Idea Fund II with \$31.5 million dollars of committed capital. The lead investor for the fundraising is Edge Ventures, the Gundersen Healthcare System corporate venture fund. The Badger Fund committed \$3 million dollars to Idea Fund II.

SMK, the Badger Fund General Partner, is committed to building the venture capital ecosystem by contracting with Wisconsin-based service providers. In June 2024, the Badger Fund conducted a formal Request for Proposal (RFP) process to identify and contract with a Wisconsin-based financial administration service provider. Previously financial administration was administered outside of Wisconsin. The RFP responses were evaluated and scored by an independent consultant.


Wisconsin Venture Capital Investments


Badger Fund has invested in six venture capital funds. Three of the funds, Gateway Capital Fund, the Winnow Fund, and Idea Fund of La Crosse II, are actively making investments in new portfolio companies. The other three funds, Idea Fund of La Crosse I, Winnebago Seed Fund, and Rock River Capital Partners are making follow on investments in existing portfolio companies.

National Venture Capital

Venture capital financial returns are generated through exit activity. The Badger Fund portfolio funds investment model assumes that portfolio companies require three rounds of investment and an exit value of \$35M to \$50M to generate a national average return.

The NVCA figure shows the total number of exits and total dollar value of exits by year. Exit dollar values





Exit Activity and \$\$ Value

peaked at nearly \$400 million in 2021 but have declined. The average exit value in 2022 and 2023 was just over \$55 million, closer to Badger Fund's target exit values.

Portfolio Companies and Economic Data
