

HOMELESSNESS ASSISTANCE

Since 1985, the State of Wisconsin has committed to assisting homeless individuals and families. The state distributes program funds through a variety of decentralized approaches using formula and competitive application processes to local homeless service providers.

A variety of initiatives administered by the Division of Energy, Housing, and Community Resources (DEHCR) provide support to local agencies for emergency, transitional and permanent shelter, housing, and services for homeless persons including;

- Emergency Solutions Grant Program (ESG)
- Homelessness Prevention Program (HPP)
- Projects for Assistance in the Transition from Homelessness (PATH)
- State Shelter Subsidy Grant Program (SSSG)
- Tenant Based Rental Assistance Program (TBRA)
- SOAR (SSI/SSDI Outreach, Access and Recovery)

The funds under these programs are intended to target persons facing housing instability: 1) individuals and families who are currently in housing but are at risk of becoming homeless and need temporary rent or utility assistance to prevent them from becoming homeless or assistance to move to another unit (prevention), and 2) individuals and families who are experiencing homelessness (residing in emergency or transitional shelters or on the street) and need temporary assistance in order to obtain housing and retain it (rapid re-housing), and 3) other services such as case management and connecting people to resources.

Assistance includes: outreach, rental payments, security and utility deposits, utility payments, housing relocation and stabilization services, case management, legal services, counseling and mediation.
