 - \$49.5 million in grants to organizations that provide out-of-school care
 - \$500,000 to an organization that provides technical assistance to organizations that provide out-of-school care
- Source: Federal American Rescue Plan Act
- Administered by the Division of Enterprise Operations

PROGRAM SUMMARY — OUT-OF-SCHOOL ORGANIZATIONS

- Awards are made on a competitive basis (not first-come, first-served)
- Maximum award \$3,000,000 or 25% of the organization's FY19 operating expenses, whichever is less (\$1.5 million for Summer 2021; \$1.5 million for 2021-2022 School Year and Summer 2022)
- Payments will be made directly to eligible organizations
- Must be used for reimbursement of eligible expenditures under the program

PROGRAM SUMMARY — TECHNICAL ASSISTANCE

- Awards are made on a competitive basis (not first-come, first-served)
- \$500,000 available
- Up to two grants available
- Payments will be made directly to eligible organizations
- Must be used for reimbursement of eligible expenditures under the program

ELIGIBLE APPLICANT – BOTH PROGRAMS

- conduct operations in and have an administrative presence in Wisconsin
- in operation since at least March 1, 2019
- nonprofit, nongovernmental organization with IRS 501(c)3 tax-exempt status
- registered with the Wisconsin Department of Financial Institutions and have one
 of the following statuses as of the Grant Announcement closing date: "restored to
 good standing", "incorporated/qualified/registered", "organized", or "registered"

ELIGIBLE APPLICANT — OUT-OF-SCHOOL ORGANIZATIONS

- offer in-person care at a physical site to school-aged children ages 5-17 for a minimum of 40 hours each week during summer months and 10 hours each week during school year
- at least 1/3 of all enrolled children are ages 5-17 (measured by number of children enrolled on June 30, 2021)
- be an eligible organization whose mission and operations provide
 Wisconsin children with out-of-school programming
- follow health and safety guidelines for childcare providers outlined by DCF



ELIGIBLE APPLICANT – TECHNICAL ASSISTANCE

 be an eligible organization whose mission and operations are to provide technical assistance to out-of-school organizations



ELIGIBLE EXPENSES – BOTH PROGRAMS

 All use of funds shall be compliant with applicable provisions of the federal American Rescue Plan Act and Program provisions.



ELIGIBLE EXPENSES — OUT-OF-SCHOOL ORGANIZATIONS

Expense Period	Reimbursement Requests Accepted by DOA
Summer 2021 (May 1 through September 1)	September 2021
Fall 2021 (September 1 through December 31)	January 2022
Spring 2022 (January 1 through May 31)	June 2022
Summer 2022 (June 1 through September 1)	September 2022



EXAMPLES OF ELIGIBLE EXPENDITURES FOR OUT-OF-SCHOOL ORGANIZATIONS (NOT EXHAUSTIVE)

- Expenses incurred to address learning loss in school-age children
- Expenses incurred to increase enrollment in out-of-school organizations
- Expenses incurred to expand programs assisting high school student prepare for postsecondary education or employment
- Expenses incurred to provide mental health support and services to school-age children



ELIGIBLE EXPENSES – TECHNICAL ASSISTANCE

 Expenses must be incurred between January 1, 2021 and September 1, 2022.



EXAMPLES OF ELIGIBLE EXPENDITURES FOR TECHNICAL ASSISTANCE ORGANIZATIONS (NOT EXHAUSTIVE)

- Expenses incurred to provide professional development training to out-of-school organizations
- Expenses incurred to provide services and training to out-of-school organizations in developing and/or enhancing program quality
- Expenses incurred to assist out-of-school organizations in supporting mental health of school age children



RESTRICTIONS – BOTH PROGRAMS

- No sub awards or funds transfer to another organization (except for payment of eligible goods or services)
- See additional details in Grant Announcement and Application
- The State will enter into grant agreements with successful applicants
- The organization must maintain for at least five years records sufficient to demonstrate that the expenses were compliant with applicable American Rescue Plan Act of 2021 provisions.

 - 25% of Applicant's 2019 fiscal year operating expenses

ADDITIONAL NOTES

- Organization is solely responsible for documenting expenses are eligible under the American Rescue Plan Act.
- Ineligible cost determinations made by State or Federal audits must be repaid to the State.
- Organizations must keep records of eligible costs for 5 years.
- Withdrawal and resubmittal of applications allowed until deadline.
 - Contact Program email to withdraw an application
- No subawards
