<u>WI Public Service Commission: USF Medical Telecommunications Equipment</u> <u>Grant Program - Telemedicine Grant Application for FY2016 and FY2017</u> The Medical Telecommunications Equipment Program is a grant program under the Universal Service Fund that enables non-profit medical clinics or public health agencies to apply for funding to purchase medical telecommunications equipment (Wis. Admin. Code § PSC 160.115).

In anticipation of a highly competitive process for accessing CDBG funding, the purpose of the training is to offer potential applicants guidance and instructions in writing successful grant applications. The two application training sessions will be:

- February 24, 2016 in Madison, from 9 a.m. to 12 noon, with a webinar training option
- March 2, 2016 in Minocqua, from 9 a.m. to 12 noon

## **ATV Trail Aids**

Counties, towns, cities, villages and tribes can apply for funds to acquire, insure, develop and maintain ATV trails, areas and routes.

#### **Troutes**

Specific changes to NR 64 created Hybrid Trails ("Troutes") or all-terrain vehicle trail and route combinations. To learn more about troutes, view the Troute information at http://dnr.wi.gov/Aid/atvTrails.html. You may download the Troute information as a PowerPoint file for use in presentations.

Eligible items and funding levels:

- All terrain vehicle trails available for spring, summer, and fall reimbursable up to 100 percent of eligible maintenance costs; max: \$600 per mile
- All terrain vehicle trails available for winter riding reimbursable up to 100 percent of eligible maintenance costs; max: \$100 per mile
- Development of ATV trails and areas reimbursable up to 100 percent of eligible costs
- Major rehabilitation of bridge structures or trails reimbursable up to 100 percent of eligible costs
- Maintenance of ATV intensive use areas reimbursable up to 50 percent of eligible costs

Any costs incurred PRIOR to receipt of a grant are not reimbursable and MAY jeopardize your entire grant. Consult the ATV Application Guidelines (CF-004) for information about eligible/ineligible costs for development and maintenance projects.

#### **Ranking Priorities**

Trail funds are distributed according to the following ranked purposes (NR 64.14).

- Maintenance of existing, approved trails, areas, and routes
- Liability insurance acquisition
- Easement acquisition
- Major rehabilitation of bridge structures or trails
- Land acquisition and development of new ATV trails and areas

#### Awareness level training

Employees working at state-owned or operated facilities or employees of municipalities, tribal governments, public K-12 schools, technical colleges and universities, need to be thoroughly familiar with proper waste handling and emergency procedures relevant to their facilities operations.

The Bureau of State Risk Management sponsors this <u>free</u> training to familiarize, refresh and engage the audience with photos, videos and activities to explain requirements and best management practices for waste handling, storage, disposal and recycling. Some example products include: fluorescent lamps, batteries, laboratory chemicals, oils, antifreeze, paints, thinners, cleaners, corrosives & poisons.

#### Who should attend?

- Employees who work with hazardous chemicals
- Facility operations, maintenance, buildings and grounds management
- Employees involved with vehicle and equipment maintenance
- Laboratory workers who generate waste solvents or other chemical wastes
- Stock/supply-area workers who order, receive or store chemical products
- Supervisors who oversee personnel with the duties listed above
