I wanted to respond to a couple of comments made at the last Board of review Meeting on Sept 16, 2021. While discussing Level of Services and our police, the town chairman declared that the Village of Waterford police services are "free". I am not sure why he would make such a proclamation, when it is very clear there is a contract with the Village and the village paid close to \$400,000.00 for their police coverage. (see attached). Also, in response, the town's attorney further claimed that the town also provides for the SRO that is stationed in the high school. This also is false, and this is the response I received from the treasurer/deputy clerk when I asked her to confirm : Hi Tanya,

I am not sure if this is what you are looking for, but attached is the 2020 end of year report for the Village Police contract .

The Town does not contribute to the SRO. When the SRO is not in the school during the summer, he is scheduled in the Village.
