WHEREAS, sec. 66.0307 Wis. Stats. allows participating municipalities to enter into cooperative boundary plans, and




NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Waterford as follows:

4. That in the event a similar resolution is passed by each of the participating municipalities, notice of this resolution shall then be given in writing to various authorities within 5 days after the resolution is adopted to the various authorities set forth in , pursuant to sec. 66.0307(4)(a), Wis. Stats., and a joint public meeting hearing shall be held no earlier than 60 days of after adoption of the last resolution by a participating municipalitys, pursuant to sec. 66.0307(4)(b), Wis. Stats.


