DNR Local Assistance Grants – Start Planning Now!

The Department of Natural Resources (DNR) partners with local governments through a wide variety of grant programs. For example, Knowles-Nelson Stewardship Local Assistance, Federal Land and Water Conservation Fund, and Federal Recreational Trails Program grants support land acquisition and construction of trails, canoe/kayak launches, fishing piers, and other local outdoor recreation facilities. Applications are due May 1, 2019.

Companies Invited to Promote their Wisconsin-Made Products

developed a Made In Wisconsin
logo for companies to use. The
logo can be adapted to reflect
your production processes.

There is no cost to use this certification mark. Companies that wish to participate fill out a simple application stating how they will use the logo and certifying that the product or service on which they seek to use the mark fulfills program requirements.

More than 200 companies in a variety of industries are now part of the program and logos are being placed on all sorts of products—from park benches to popcorn to handbags to heaters.

Communities Urged to Apply for Certified Sites Programs

In January, WEDC will begin accepting applications for the Certified in Wisconsin® Program, a designation that ensures that an industrial property is development-ready and allows for fast-track construction for major relocation or expansion projects.

Once a site is certified, a potential developer has all the standard information generally needed to make a quick decision about whether that site is right for their needs, such as utility and transportation infrastructure, environmental assessments, quality of nearby labor force and much more.



To date, there have been 19 economic development projects on the state's Certified Sites—which are expected to result in more than \$400 million in capital investment and more than 2,300 jobs. News from DATCP

These are challenging times for Wisconsin farmers. Here are resources from the Wisconsin Department of Agriculture, Trade & Consumer Protection (DATCP) that may help.

Agricultural Enterprise Areas

If your community could benefit by being designated as an agricultural enterprise area, gather local officials, landowners, and agribusiness owners to submit a petition by the June 21, 2019 deadline for 2020 designation.

Agricultural enterprise areas, or AEA's, are blocks of land that are used primarily for farming and businesses that serve the farming sector. They are created when at least five landowners and their local governments petition for an AEA designation and DATCP approves the petition.

Farmers in AEA's may qualify for tax credits. The designation can also be used with local planning and zoning, conservation easements, agriculture economic development incentives, and other tools to support farming and the local farm economy, while providing certainty for farmers making investment decisions.

Wisconsin Farm Center Resources

Industrial Hemp License Period Runs Through March 1

The Department of Agriculture, Trade and Consumer Protection is accepting industrial hemp license applications and annual registrations for the 2019 growing season until March 1, 2019.

Growers and processors who received licenses in 2018 do not need to reapply for licenses, however, will need to register for the 2019 season. Those who do not have a license will need to apply for one and register if they intend to grow or process in 2019.

This will be the only licensing and registration period for the 2019 growing season. Licensing materials, fee information, other details about the program are available at
