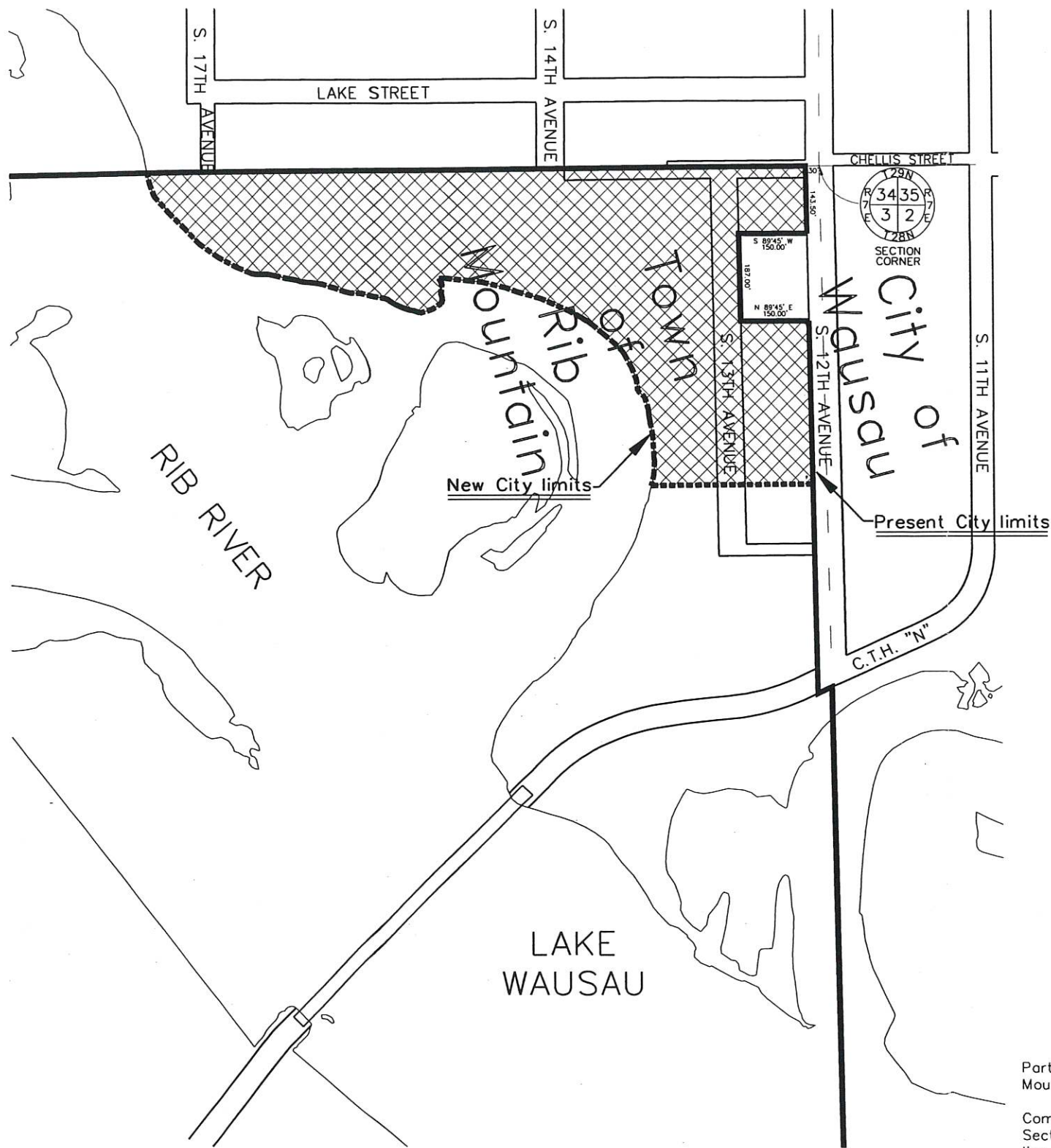
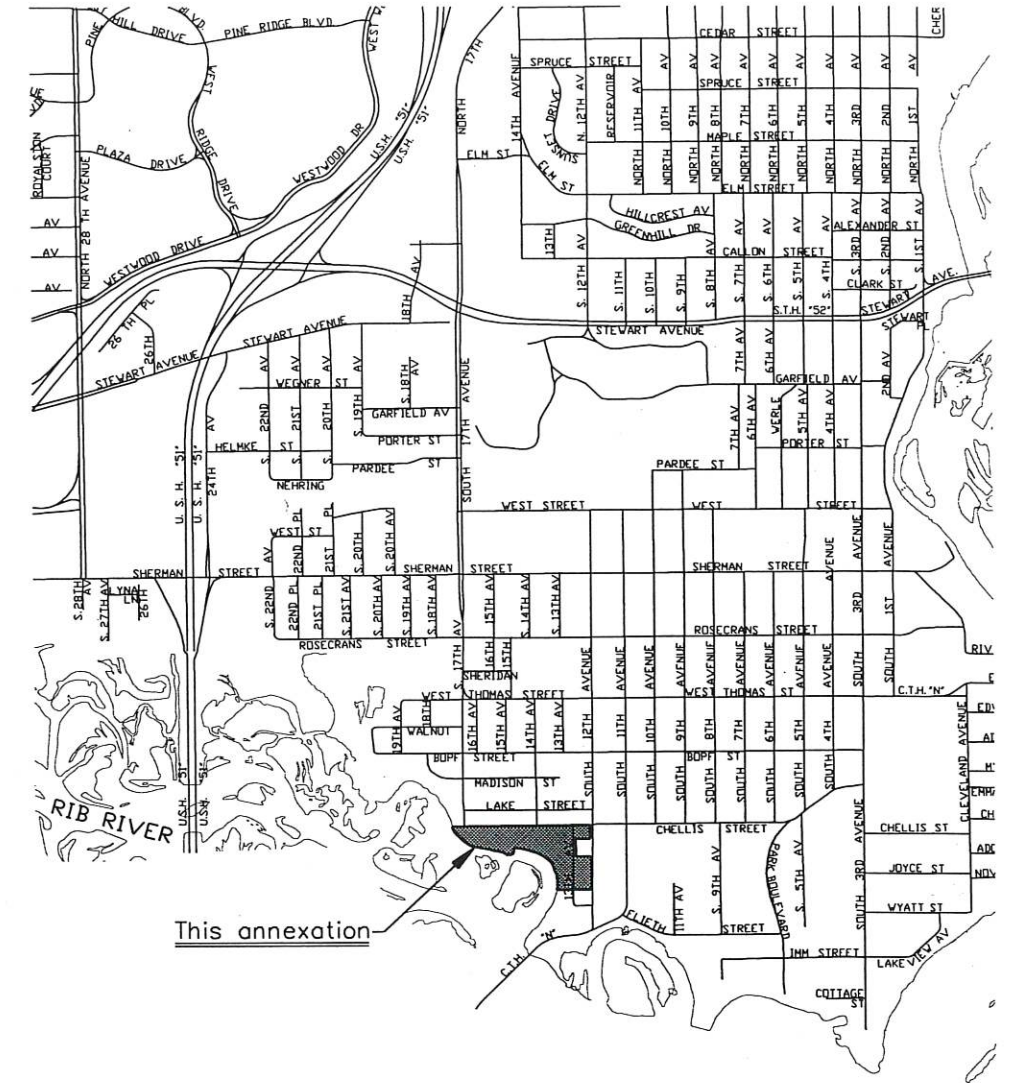

**Legal Description for Annexed Land**

Part of the NE1/4 of Section 3, Township 28 North, Range 7 East, Town of Rib Mountain, Marathon County, Wisconsin, described as follows:  
  
Commencing at the corner common to Section 34 and 35, Township 29 North, and Sections 2 and 3, said Township 28 North, Range 7 East; thence West along the North line of said Section 3, 30.00 feet to the point of beginning.  
  
Thence South parallel with the East line of said Section 3, 143.50 feet; thence S89°45'W, 150.00 feet; thence South, 187.00 feet; thence N89°45'E, 150.00 feet; thence South parallel with the East line of said Section 3, to the Southerly line of the parcel described in Micro Records in Volume 205 on page 752; thence West, along said South line, 150.00 feet to the East right-of-way of South 13th Avenue; thence West to the Southeast corner of the parcel described in Micro Records in Volume 538 on page 1072; thence West, along the South line of said parcel, to the Easterly shoreline of the Rib River; thence Northerly and Westerly, along the Easterly and Northerly shoreline of the Rib River, to the North line of said Section 3; thence West, along said North line to a point 30 feet West of the Northeast corner of said Section 3, the point of beginning.
