

ORDER

This matter, having come before the Court on November 21, 2019, on the Petitioners' Petition for Incorporation, and the Court, having considered the Petition and having heard the Motion to Become a Party in the Proceeding filed by the Village of Wrightstown, and the Petitioners, being represented by Attorneys Anthony J. Steffek and James M. Kalny of Davis & Kuelthau, s.c., and the Village of Wrightstown, being represented by Attorney Robert R. Gagan of the Law Firm of Conway, Olejniczak & Jerry, S.C., and such counsel having presented to the Court, and the Court, upon consideration of the materials contained in the record of this proceeding and upon receiving presentations from counsel;

IT IS HEREBY ORDERED that the Court finds that Petitioners have met the standards set forth in Wis. Stat. § 66.0205 and, accordingly, refers the Petitioners' Petition for Incorporation to the Wisconsin Department of Administration Incorporation Review Board; and

IT IS HEREBY FURTHER ORDERED that the Motion to Become a Party in the Proceeding filed by the Village of Wrightstown is granted, and the Village of Wrightstown is made a party in interest in this action.
