2021 Annual Report to the Governor and Legislature

2021 saw continued challenges from the COVID-19 pandemic and their effects on the ability to provide housing and services for our state's most vulnerable. The scope of these challenges was not reflected in the standard counts of people experiencing homelessness. The annual point-in-time (PIT) count in January, which was affected by fewer people being able to volunteer for the count, recorded 4,237 people in emergency shelters, transitional housing, Safe Havens or unsheltered. While that reflected fewer people than were counted in the PIT count in 2020 (4,515), 669 people experiencing chronic homelessness (defined as a single individual, or head of household, with a disabling condition who has either experienced homelessness for longer than a year, during which time the individual may have lived in a shelter, Safe Haven, or a place not meant for human habitation or experienced homelessness four or more times in the last three years) were counted - a number more than 10% higher than the number counted in 2020.

The Department of Public Instruction reported 17,179 students experiencing homelessness (defined as children and youths as those who lack a fixed, regular, and adequate nighttime residence) served by the Education for Homeless Children and Youth program in Wisconsin schools for the 2019-2020 school year. The significant drop in students served compared to the previous year (18,349) is attributed to the number of schools that ended in-person schooling during the year.

Response to COVID-19

The pandemic continued to have a substantial effect on the operations of agencies serving people who experienced homelessness in 2021. Emergency shelters continued to contend with having to serve people while adhering to U.S. Centers for Disease Control Prevention guidelines for social distancing in emergency shelters.

Unsheltered homelessness due to the lack of affordable housing, lack of shelter opportunities, and a myriad of economic and social conditions continued to be a growing concern in Wisconsin in 2021. Agencies serving people experiencing homelessness continue to do heroic work to keep as many people safe as they are able and working to move more people into housing - though many barriers to sustainable housing situations still exist.

State government continues acting to help homeless people and to keep people in housing and out of the homelessness system. These efforts include:

- The Department of Administration’s Division of Energy, Housing and Community Resources (DEHCR) completed its work in allocating over \$32 million in HUD Emergency Solutions Grant funding provided by the CARES Act and over \$12 million in Community Development Block Grant funds provided by

the CARES Act for funding projects and services such as new emergency sheltering, food pantry assistance, rental assistance, hotel vouchers, and other housing/homelessness supports.

- DEHCR launched the Wisconsin Emergency Rental Assistance (WERA) program in February - a partnership with Wisconsin Community Action Program Association agencies throughout the state to use \$322 million in funding provided by the US Department of Treasury from the Consolidated Appropriations Act of 2021 for emergency rental assistance in "non-entitlement areas" (defined in this instance as the entire state - excepting Brown, Dane, Milwaukee and Waukesha Counties as they received their own funding). As of December 30th, over \$95 million has been distributed to assist nearly 25,000 Wisconsin households with rental assistance and assistance for other housing costs. This investment kept those households in housing and out of eviction court.
- On August 24th, Governor Evers announced a new \$200 million Neighborhood Investment Fund program funded by the American Rescue Plan Act (ARPA) to provide funding to local and Tribal governments for making significant investments with long-term benefits in order to help neighborhoods recover from negative effects of the COVID-19 pandemic. Project awards are expected to be announced in early 2022.
- In response to concerns of growing unsheltered homelessness throughout the state as we entered winter, Governor Evers announced on November 16th the creation of the Safe Shelter and Homelessness Grant program with \$6 million in ARPA funds. For this winter, 42 agencies were allocated over \$3.3 million to expand services to bring more people into shelter over the winter.
- The Department of Public Instruction was awarded an additional \$10 million from ARPA funds for the Educating Homeless Children and Youth program. \$1.9 of those funds were distributed through a competitive process to 49 school districts.
- The Department of Veterans Affairs was awarded \$4.2 million from federal VA to make updates to VHRP facilities in Union Grove, Chippewa Falls, and Green Bay – which provide 78 beds for veterans experiencing homelessness. This will allow the facilities to transition from congregate situations to private rooms and private bathrooms. This will allow for safer living quarters.

Among the concerns highlighted, there will need to be continued outreach to get COVID vaccines to people experiencing homelessness - particularly as the Delta and Omicron variants continue to spread throughout Wisconsin.

Other Agency Highlights

Other work agencies that intersected with service to people experiencing homelessness included:

- On December 20th, the Wisconsin Housing and Economic Development Authority (WHEDA) and the WHEDA Foundation announced \$1 million in awards in its annual Housing Grant program. 34 agencies were awarded Emergency/Transitional and Permanent Housing grants for projects to assist 865 beds in communities throughout the state.
- Also, in 2021 WHEDA announced the launch of the Wisconsin Supportive Housing Institute - a partnership with the Corporation for Supportive Housing to increase supportive housing development in communities across Wisconsin by training teams on ways to reduce the time it takes to obtain funding for supportive housing by improving the planning and development process.
- In November, the Department of Children and Families launched the Living Independently Through Financial Empowerment with \$14 million in ARPA funds to assist domestic violence survivors whose safety is at risk and assist them in becoming financially empowered to live independent, violence-free lives. This funding could be used to secure independent housing for applicants. The funds were obligated within weeks - with over 4,000 individuals being assisted.
- The Department of Corrections started a program to provide supportive housing beds for persons releasing from prison. \$600,000 was invested in the new model to provide 44 SH beds in Janesville and Milwaukee. In FY 22, \$800,000 will be invested to grow the program in other regions.

Welcoming Wisconsin Home

This year, we were proud to complete "Welcoming Wisconsin Home: A Statewide Action Plan for Homelessness 2021-2023". This was the result of over two years of work reviewing the previous state plan and included several public meetings and opportunities to provide input and ideas. The Plan will be publicly released in January 2022.

We are particularly proud of achieving two goals we had through the process. One was adding a much-needed section on addressing racial disparities in the homelessness systems and housing markets in Wisconsin. The other was updating the "Performance Metrics" section to include details on responsibilities for implementing strategies, timelines, and (where possible) measurable goals. The plan includes 40 recommendations, which the Council will begin work to implement in 2022.

Wisconsin Eviction Data Project

In May, the Council launched the Wisconsin Eviction Data Project. For the first time in state history, there is an opportunity for policymakers, advocates, and the public to have access to real-time data on the number of evictions filed and eviction judgements rendered per county, per month.

The purpose of this project was to provide an accurate picture of evictions in Wisconsin to measure the efficacy of programs and policy decisions and to spark community discussions on the number of evictions in local areas and how they affect communities. Additionally, we can use raw data to inform CAP agency partners on who is having evictions filed so they can be directed to interventions such as WERA to avoid eviction judgements. Director's Activities

From Michael Basford, Interagency Council on Homelessness Director:

In June, I assisted the Department of Public Instruction's Education for Homeless Children and Youth team with their evaluations of applications for the ARP-HCY grants.

A significant amount of time was spent in 2021 working with the State Medicaid Learning Collaborative in advance of the submission of the Medicaid state plan amendment. I fully commend the leadership Leah Ramirez from DHS provided through this process and look forward to CMS approving the amendment and implementing the program in 2022.

Additionally, I would also fully commend the leadership and hard work of Alfred Johnson, John Longo and Robby Stoikes of the Emergency Support Function #6 Team. They continued to organize bi-weekly meetings with the CoC leads, federal partners, and Red Cross to strategize and share information on how homelessness services could be assisted during the pandemic. They organized DHS' monthly Homelessness Forum to provide vital information to providers of services for people experiencing homelessness (<https://www.dhs.wisconsin.gov/preparedness/homelessness.htm>). They were instrumental in the success of our efforts to move emergency shelter workers to Tier 1 for the Covid vaccine rollout. And in the new year they are organizing meetings to continue to troubleshoot local issues with homelessness with state agency representatives.

This fall, I co-authored with Carrie Poser an article for the Housing Assistance Council's *Rural Voices* magazine. "Wisconsin Works to House Rural Residents and Eradicate Homelessness" was published in the magazine's Fall 2021 edition and can be found at <https://ruralhome.org/covid-19-leaves-its-mark-rural-america/>.

In 2022, I plan to continue to work with national agencies like the National Alliance to End Homelessness, National Low-Income Housing Coalition, Corporation for Supportive Housing, Urban Institute and others to explore options to help facilitate development for low-income affordable housing – the availability of which is our largest challenge to our efforts to move people from homelessness into housing.”

Looking forward

The Interagency Council on Homelessness looks forward to the following in 2022:

- Beginning of implementation of the action steps in “Welcoming Wisconsin Home”;
- Continuing our COVID-19 responses to help our most vulnerable in Wisconsin; and
- Return to onsite visits with our partners throughout Wisconsin.
