Cloud Services Contracts- Background

- In 2016, NASPO issued an RFP for cloud services inclusive of SaaS, IaaS, PaaS (Utah was the lead state).
- Wisconsin actively participated on the solicitation team in order to add as many of our requirements as possible, including state standard terms and conditions.
- 31 vendors were awarded contracts initially. An additional 30 were awarded during the 2018 refresh.
- The 61 vendors with current awards cover the spectrum of cloud solutions, from Call Centers to Background Checks.

Cloud Service Categories - PaaS

- Platform as a service (PaaS) is a complete development and deployment environment in the cloud, with resources that enable you to deliver everything from simple cloud-based apps to sophisticated, cloud-enabled enterprise applications.
- Platform as a Service (PaaS) is a complete cloud environment that includes everything developers need to build, run, and manage applications—from servers and operating systems to all the networking, storage, middleware, tools, and more.







Cloud Service Categories - IaaS

- Infrastructure as a service (IaaS) is a type of cloud computing service that offers essential compute, storage, and networking resources on demand, on a pay-as-you-go basis.
- IaaS is one of the four types of cloud services, along with software as a service (SaaS), platform as a service (PaaS), and serverless.







Cloud Service Categories - SaaS

- Software as a service (or SaaS) is a way of delivering applications over the Internet—as a service.
 - Instead of installing and maintaining software, you simply access it via the Internet, freeing yourself from complex software and hardware management.
- SaaS applications are sometimes called Web-based software, ondemand software, or hosted software
 - Whatever the name, SaaS applications run on a SaaS provider's servers.
 - The provider manages access to the application, including security, availability, and performance.

Cloud Contracting Basics – How Do I Get Started?



Draft your requirements

- Work with you program area and IT resources to document specifically what you need
- Identify a specific product that meets your solution
- Contact Carahsoft or Unisys to determine if they can provide that product
- Unsure of the product that meets your requirements just ask!





Participating Addendum

Reflects the terms and conditions in the solicitation (link)

- State of Wisconsin standard Commodities terms (pg.223)
- Data Security (pg.65)





Engagement Addendum

- Identifies the governing State Participating Addendum (PA)
- Details the scope of what is being purchased
- Includes any additional terms and conditions







License/ Service Agreement Software License vs. Software-as-a-Service agreement

Software Licensing - the software is made available to the licensee as a **tangible product.** Software-as-a-Service (SaaS) – a "service" model offering with no

tangible product.





Software Licensing - the software is made available to the licensee as a tangible product.

- physical piece of software
- electronically provided (download)
- downloaded, installed, run, and operated on a piece of hardware (physically on site or data center)
- services associated:
 - ➢implementation
 - ➤ customization
 - ≻training
 - >maintenance and technical support





Software-as-a-Service (SaaS) – a "service" model offering with no tangible product.

- only available "on the cloud" as a hosted platform
- Includes maintenance service, hosting and technical support
- services associated:
 - implementation
 - customization
 - ➤ training
 - maintenance and technical support





Data Security Terms – Why it's important

- you never receive a physical product
- no control over data security in the platform
 - \circ Average cost of a data breach in the United States \$9.44M (IBM, 2022)
- Service Level Agreements (SLA):
 - > Ability to access the platform (uptime)
 - accessing and downloading your data from the platform (specific format or understand the format offered. May be customized for a fee.



Data Security Terms – What's included under PA's

- Solicitation included the <u>standards</u> (link) established by the Center for Digital Government published
- Used as the basis to develop standards for DOA





Professional Services Terms

- Will govern any of the professional services (implementation, training, etc.)
- Are different from the "Services" available from the platform
- Obtain from Publisher
- Negotiate, Negotiate, Negotiate
