JOINT COMMITTEE ON FINANCE

Minutes of the Meeting Under s. 13.10

August 4, 2009

Co-chair Miller presided and called the meeting to order at 10:45 a.m.

Present: Senators Miller, Hansen, Taylor, Lehman, Robson, Lassa, Darling, Olsen Representatives Pocan, Mason, Shilling, Sherman, Grigsby, Vos, Montgomery

Absent: Representative Colón

I. Department of Health Services

Moved by Senator Miller and seconded by Representative Pocan to approve the expenditure of \$3,999,200 of American Recovery and Reinvestment Act funds by the department in the 2009-11 fiscal biennium to support the following activities in the Birth-to-Three program: (a) the promotion of evidence-based practices ("legacy building"); (b) cross-agency and cross-program collaboration; and (c) information technology improvements. In addition, direct the administration to resubmit the request for the allocation and expenditure of \$3,000,000 when the final county allocations have been determined.

II. Department of Health Services

Moved by Senator Miller and seconded by Representative Pocan to approve the Governor's request to allow the department to allocate and expend American Recovery and Reinvestment Act funds in the amounts of \$496,263 in fiscal year 2009-10 and \$27,975 in fiscal year 2010-11 for electronic benefits transfer related activities in the Women, Infants and Children (WIC) program and to purchase computer hardware for use by local WIC projects.

The amounts reflect updated estimates on the cost of hiring 4.0 FTE project positions.

IX. Department of Commerce

Moved by Senator Miller and seconded by Representative Pocan to approve the expenditure of \$1,344,000 in fiscal year 2009-10 of American Recovery and Reinvestment Act funds for the lead hazard control program, including \$1,144,000 in the appropriation under s. 20.143(2)(m) for grants and \$200,000 in the appropriation under s. 20.143(2)(o) for the department's administrative costs. The Governor may submit a request for the remaining \$1,656,000 when the grant recipients are identified.

Further, specify that if the department or the Department of Commerce proposes to spend any of the Recovery Act funding for sites other than the sites included in the April 2009 application to EPA, the Governor shall first submit a request to the Committee for approval of the expenditures under the requirements of 2009 Wisconsin Act 2.

Without objection, it was so ordered.

XXII. Department of Administration

Moved by Representative Mason and seconded by Senator Taylor to approve the request to provide increased expenditure authority of \$11,743,000 in fiscal year 2009-10 in the appropriation under s. 20.505(1)(mb) to appropriate Energy Efficiency and Conservation Block Grant funds allocated under the American Recovery and Reinvestment Act. Further, direct the Departments of Commerce and Administration in administering grant awards to ensure, to the extent allowable by state and federal law, that local labor and businesses are utilized for projects funded with the federal Energy Efficiency and Conservation Block Grant.

XXIV. Department of Administration, Office of Justice Assistance

Moved by Senator Taylor and seconded by Representative Grigsby to approve the Governor's recommendation to increase the expenditure authority to the department's Office of Justice Assistance (OJA) federal aid; criminal justice appropriation [s. 20.505(6)(n)] by \$15,140,000 in fiscal year 2009-10 and its federal aid, justice assistance, state operations appropriation [s. 20.505(6)(m)] by \$1,200,000 in fiscal year 2009-10, to permit American Recovery and Reinvestment Act funds to be utilized for criminal justice-related activities and for OJA administration costs under the Byrne Justice Assistance Grant program.

In addition, specify that the \$300,000 under the Recovery Act Justice Assistance Grant Plan set aside for the traffic stop data collection initiative under 2009 Wisconsin Act 28 be utilized for: (a) OJA staff time and expenses to develop the plan required under Act 28; and (b) local law enforcement agency information system equipment and software purchases to the extent that funding is not fully expended under (a).

Require OJA to create an advisory committee to develop the administrative rules for the program required under Act 28. Provide that the advisory committee be composed of two members of the Joint Committee on Finance, one appointed by the Senate Co-chair and one appointed by the Assembly Co-chair. Specify that the remaining committee members include representatives of law enforcement, the community and criminal justice professionals. Require the committee to hold public hearings throughout the state in developing the required administrative rules.

Further, approve the Governor's recommendation to increase the expenditure authority to the OJA federal aid, local assistance and aids appropriation [s. 20.505(6)(p)] by \$2,293,900 in fiscal year 2009-10, and its federal aid, justice assistance, state operations appropriation [s. 20.505(6)(m)] by \$254,800 in fiscal year 2009-10, to permit American Recovery and Reinvestment Act funds to be utilized for programs to improve the criminal justice system's response to violence against women, to improve services available to women victims, and for OJA administration costs under the STOP Violence Against Women formula grant program.
