Minutes of the Meeting under s. 13.10

December 5, 2023

Co-Chair Marklein presided and called the meeting to order.

I. Department of Public Instruction

Moved by Representative Andraca and seconded by Representative McGuire to approve a supplement of \$111,000 GPR in fiscal year 2023-24 and \$225,400 GPR in fiscal year 2024-25 from the Committee's appropriation under s. 20.865(4)(a) to the department's general program operations appropriation under s. 20.255(1)(a) and the creation of 1.0 FTE GPR position in unclassified service for the director of the Office of Literacy. The supplement would support the cost of the position and the payment of annual stipends to members of the Council on Early Literacy Curricula created in 2023 Wisconsin Act 20.

Specify that of the total amount, in fiscal year 2023-24, \$62,400 shall be for salary, \$26,200 for fringe benefits, \$7,900 for fixed costs, \$8,000 for IT and desktop support and \$2,000 for travel and events. In fiscal year 2024-25, \$135,200 shall be for salary, \$56,700 for fringe benefits, \$17,000 for fixed costs, \$8,000 for IT and desktop support and \$4,000 for travel and events.

The positions would support administrative functions within the Division of Market Regulation, Division of Financial Regulation, Legal Unit and Office of Operational Management.
