## BACKGROUND

This section provides the schedule for the State’s first year-end appropriation certification and closing under STAR. Section 16.52(5)(b), Wisconsin Statutes requires agencies to completely reconcile their records with DOA. And, each agency is required to appoint an Agency Reconciler. This reconciler will be required to approve and submit an Annual Appropriation Certification (AAC) form for each appropriation they are responsible for (this will replace the previous “Form 78” process).

## POLICIES

The following schedule shows the due dates for year-end activity. Completion of those items marked with a “Y” in the “Agency Confirm” column must be confirmed by the Agency Reconciler to the SCO via an email sent to the “DOA SCO Year End” functional email address.
