## BACKGROUND

State agencies will sometimes receive incorrect payment amounts from their customers, and all or a portion of the payment must be returned. Since the incoming payment is usually recorded to a revenue account, the outgoing refund payment to the customer debits the same revenue account. This is problematic in STAR, because the Project Costing subsystem assumes that payments made through the Accounts Payable subsystem are related to expenditures — even though a revenue account is utilized. This creates an imbalance between the General Ledger and the Project Costing subsystem.

### **POLICIES**

A balance sheet account has been established to record outgoing refund of revenue payments that
involve projects. Agencies must use this account on their payment transaction (without a project code),
and then process a GL journal transaction to reverse the balance sheet entry and record the revenue
debit to the project.
