Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1997, Series D (Taxable) (the "Bonds"), pursuant to Section 1.6(c)(i) of the authorizing resolution, as amended, that a portion of the Bonds maturing on November 1, 2003 through 2012, 2017 and 2028 have been called for redemption on October 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to October 1, 2003.
