Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1997, Series D (Taxable) (the "Bonds"), pursuant to Section 1.6(c)(i) of the authorizing resolution, as amended, that a portion of the Bonds maturing on November 1, 2004 through 2012, 2017 and 2028 have been called for redemption on December 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to December 1, 2003.

On and after December 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
