Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1998, Series F (Taxable) (the "Bonds"), pursuant to Section 1.06(c) of the authorizing resolution providing for the special redemption of the Bonds, that a portion of the Bonds maturing November 1, 2004 through 2009 and 2029 have been called for redemption on December 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to December 1, 2003.

On and after December 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
