Notice is hereby given to CEDE & Co. the owner of State of Wisconsin General Obligation Bonds of 1996, Series B (AMT) (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds from prepayments of veterans housing loans financed by public debt issued for such purpose, that some of the Bonds maturing on 2009 through 2013 and 2021 have been called for redemption on April 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to April 1, 2003.

On and after April 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
