## STATE OF WISCONSIN General Obligation Bonds of 1996, Series D (AMT) Dated October 15, 1996 Maturing 2014 and 2020

Notice is hereby given to CEDE & CO. the owner of State of Wisconsin General Obligation Bonds of 1996, Series D (AMT) (the "Bonds"), pursuant to Section 1.6 of the authorizing resolution, providing for the special redemption of the Bonds from prepayments of veterans housing loans financed by public debt issued for such purpose, that a portion of the Bonds maturing 2014 and 2020 have been called for redemption on April 1, 2003 prior to their maturity at the price of 100% of their principal amount plus accrued interest to April 1, 2003.

On and after April 1, 2003 interest will cease to accrue on the principal amount so called for redemption.
