## \$80,000,000 STATE OF WISCONSIN General Obligation Commercial Paper Notes

## Ladies and Gentlemen:

We refer to the Credit Agreement, dated as of April 3, 1997 (the "Credit Agreement"), among the State of Wisconsin (the "State"), acting through the State of Wisconsin Building Commission, and The Bank of Nova Scotia, New York Agency ("The Bank of Nova Scotia" or the "Bank"). Capitalized terms used herein and not defined herein have the meanings set forth in the Credit Agreement.

The Expiry Date under the Credit Agreement is currently 5:00 p.m. (New York time) on March 27, 2004, as extended by multiple letter agreements between the State and The Bank of Nova Scotia, including most recently a letter agreement dated March 28, 2003.

Pursuant to Section 2.1(e) of the Credit Agreement, the State has requested that The Bank of Nova Scotia extend the Expiry Date to March 26, 2005. The Bank of Nova Scotia, by execution of this letter agreement, agrees to extend the Expiry Date under the Credit Agreement to March 26, 2005.

The Commitment is currently \$85,000,000. In accordance with Section 2.1(d) of the Credit Agreement, the State has requested that The Bank of Nova Scotia reduce the Commitment to \$80,000,000 effective March 27, 2004, which the Bank, by execution of this letter agreement, agrees to do. The amount of the Commitment that The Bank of Nova Scotia shall be obligated to advance shall be the amount of the Commitment as so reduced.

Other than as set forth in this letter agreement, all of the other terms and provisions of the Credit Agreement shall continue in full force and effect.

If the State is in agreement with the terms of this letter agreement, please cause each of the four enclosed copies of this letter to be duly executed by the State and returned to The Bank of Nova Scotia, whereupon this letter agreement shall constitute an amendment to the Credit Agreement and shall be binding on the State and the Bank, effective as of the date first set forth above.
