	A portion of the amounts available in the Loan Credit Reserve Fund consists of a Debt Service Reserve Insurance Policy issued by XL Capital Assurance Inc. in the amount of \$17 million. As a result of the recent downgrade of XL Capital Assurance Inc. to a rating category lower than AA, the Debt Service Reserve Insurance Policy from XL Capital Assurance Inc. may no longer be included in determining whether the Loan Credit Reserve Fund Requirement has been satisfied.
	After application of a portion of proceeds from pending issuance of the Clean Water Revenue Bonds, 2008 Series 1 (2008 Series 1 Bonds) and other funds available to the State, upon closing and delivery of the 2008 Series 1 Bonds and Clean Water Revenue Refunding Bonds, 2008 Series 2, amounts available in the Loan Credit Reserve Fund will satisfy the Loan Credit Reserve Fund Requirement.
