On December 17, 2012 the State will redeem a portion of the bonds maturing November 1, 2029. The enclosed Notice of Partial Redemption is being sent to you pursuant to Representation 3 of the Letter of Representations, dated June 18, 1998, between the State of Wisconsin Building Commission and The Depository Trust Company ("DTC"). The Letter of Representations requires that DTC be notified not less than thirty days prior to the date of redemption. You will have this letter and the Notice in your possession on November 16, 2012, a date which is more than 30 but less than 60 days prior to the proposed date of redemption.

Representation 14 gives DTC the option of requesting a new bond certificates in the revised amount or making the appropriate notation on the existing bond certificates. Please advise us which option you choose.
