## **Award Process**COVID-19 Cultural Organization Grant Program November 3, 2020

## **Background**

Governor Tony Evers has designated \$15,000,000 from the federal Coronavirus Aid, Relief and Economic Security (CARES) Act to assist cultural organizations whose operations have been negatively affected by COVID-19. Administered through the Department of Administration (DOA), the COVID-19 Cultural Organization Grant Program (Program) will provide grants of up to \$250,000 to eligible organizations. The purpose of this document is to provide interested parties information on the award process for the Program as defined in the Grant Announcement, issued September 3, 2020. The Grant Announcement provided the following Method of Award governing allocation of funds:

**Section 3.6 Method of Award.** The State will compile the final scores for each application (see section 3.3). The State intends to award to one or more applicants for the resulting grant agreement(s). Awards will be based upon the highest scoring responsive and responsible applicant(s). The State reserves the right to negotiate, limit or amend awards in accordance with objectives of the program. (*Source: Grant Announcement, p. 6*)

## **Process**

- 1. **Eligibility**. The program received 419 proposals prior to the application deadline of September 30, 2020 at 2:00PM CST, each of which were reviewed for compliance with the grant announcement.
  - Twenty-seven (27) proposals were disqualified due to applicant ineligibility.
  - Seven (7) proposals were incomplete and were disqualified.

Further, the Program adjusted proposals that made grant funds requests in excess of the amounts identified in Section 3.5 of the Grant Announcement to the lesser of \$250,000 or 25% of the organization's average three previous fiscal years of operating revenue. Finally, the Program adjusted grant requests that included ineligible costs as identified in an applicant's proposal.

2. **Scoring**. All applications were divided among nine evaluators who independently scored a applications on a 100-point scale. Evaluators awarded points in each section for complete responses that met the criteria of the section. Points were awarded in the following categories:

3. **Applicant Scores, Budget Adjustment and Award**. The total allowable grant request (\$27,230,664.49) among eligible applicants exceeded available Program funding (\$15,000,000.00). Therefore, a budget adjustment factor of 55.08% (\$15,000,000.00/\$27,230,664.49) was applied to each eligible proposal's allowable request to determine an applicant's award.
