#### Wisconsin's First Elk Hunt!

Following more than 22 years of elk management and reintroduction efforts, 2018 will mark Wisconsin's first managed elk hunt in state history. Get the full story by watching this video.

Only Wisconsin residents are eligible to purchase an elk tag. The application fee is \$10 and applications will be available starting May 1 through the Go WILD system at GoWild.wi.gov For more information, go to dnr.wi.gov and search keyword "elk."

#### EAB Quarantine Cuts Regulatory Requirements for Wood Industry

The Department of Agriculture, Trade and Consumer Protection (DATCP) has placed the entire state of Wisconsin under quarantine for emerald ash borer (EAB), effective March 30.

Until now, quarantines have been imposed county by county, until 48 of the 72 counties were quarantined. Under that system, businesses handling ash wood, untreated ash products and hardwood firewood had to sign agreements specifying how they would reduce the risk of moving EAB into non-quarantined areas. With all 72 counties quarantined, those products can move freely within the state during the entire year.

This DATCP webpage has information about emerald ash borer identification, locations, management, laws and much more. The information is for homeowners, community leaders, green industry professionals, scientists, and anyone who enjoys the outdoors.

Wis. Commercial Building Code is Awaiting Publication

The effective date for the updated rules will be May 1, 2018.

#### Department of Revenue Works to Find Owners of Unclaimed Property

The Wisconsin Department of Revenue (DOR) has managed the unclaimed property program since 2013 and has returned more than \$128 million in unclaimed property.

Unclaimed property includes funds from savings or checking accounts, uncashed dividends, insurance policies, or other accounts that the owner may have forgotten. Institutions such as banks, credit unions, insurance companies and other businesses are required to report unclaimed property to DOR each year by November 1. DOR then holds the property for safe keeping until it is claimed by the owner.

In 2015, DOR began using state tax data to locate owners of unclaimed property. This matching program makes the process more efficient and benefits residents not aware they have unclaimed property.

#### State Law Prohibits Drivers From Using Hand-Held Cell Phones In Work Zones

With the state's highway construction season getting started, the Wisconsin State Patrol reminds motorists that state law prohibits drivers from using a handheld mobile device in a Wisconsin work zone. Violators face fines of up to \$40 for a first offense and up to \$100 for subsequent offenses. There is an exception to report an emergency.
