DET Service Delivery

The following programs impact the **homeless population** or **those at risk of homelessness**:

- Job Services
 - Our frontline staff work directly with homeless individuals and make appropriate referrals
- Office of Veterans Employment Services
 - Using federal funds, staff work with homeless veterans
- WIOA
 - A federal program providing workforce services and training to barriered populations

DET Service Delivery Strategy

- DET partners with local Workforce Development Boards to implement WIOA Title 1 programs focusing on the adult, youth, and dislocated worker populations
- Job services are provided in-person, virtually, and over the phone by DWD staff
- Veterans with 30% or more service-connected disability are served by our Office of Veterans Employment Services
- All of our participants are tracked in an internal database called ASSET
