State Awards \$3.2 Million in Housing Grants

Grants help low to moderate income families rent or own safe, affordable housing

The Department of Administration (DOA) announces that communities across Wisconsin will receive a total of \$3.2 million in Housing Cost Reduction Initiative (HCRI) grants. HCRI was created by the State in 1989 to provide housing assistance to low and moderate income families seeking to own or rent decent, safe, affordable housing.

"Safe and affordable housing should be accessible to all Wisconsin families" said DOA secretary Mike Huebsch. "This initiative helps families statewide get help with buying a home or saving their home from foreclosure."

HCRI grants are administered by DOA's Division of Housing through a biennial competition. These funds are designed to provide funding for HCRI eligible activities:

- **Homebuyer:** Help eligible homebuyers purchase affordable homes by providing down payment, closing cost, and/or gap financing assistance.
- **Foreclosure:** Help homeowners prevent foreclosure by producing payments to cover mortgage, property tax, principal, interest, and/or arrearages.
